Summary

Across 2020, the Government of Somaliland collected a total of 2.009 trillion SLSh in domestic revenue and received 1.050¹ billion SLSh from the World Bank for a talent management program. Total collection was therefore 2.010 trillion SLSh, equivalent to 287 million USD. key revenue items for 2020 included taxes on imports and sales taxes, making up over 54% of total revenue between them. In spite of the global pandemic, total revenue collection was 12.4% or 221.5 billion SLSh higher than 2019 collections, primarily due to strong performance on import tax revenues (collecting an additional 86 billion SLSh in 2020) and tax on business income, which grew by 190% (or an additional 24 billion SLSh). Monthly revenue collections were lowest in the first part of the year, in line with previous trends but accentuated by the global downturn following the COVID-19 pandemic and the associated restrictions. Revenue collection patterns were otherwise similar to previous years, with Customs and IRD performance peaking in the fourth quarter of the year. In relation to meeting revenue targets, domestic revenue collection in 2020 was 30 billion SLSh (-1.5%) lower than the budget target. Inland Revenue collections were 10% higher than targeted, while Customs collections were 5% lower than the target largely due to their greater exposure to the effects of the pandemic (e.g. trade restrictions).

On the expenditure side, the government spent 1.962 trillion SLSh in 2020 from the General Government Fund, representing 95.9% of the 2.046 trillion SLSh Parliament approved Budget—or a 4.1% underspend. This underspend was a result of several factors that include the late recruitment of new employees given that most of the MDAs were operating at less than full capacity in the second quarter of the year—resulting in lower spending on compensation of employees and Use of Goods & Services. Moreover, 56.4 billion SLSh or 2.8% of the approved budget was restricted during the year. This was a precautionary measure by the Ministry of Finance to safeguard the fiscal health of the government in the event of unexpected expenses that might arise as a result of the COVID-19 pandemic².

In FY2020, a 55.6 billion SLSh supplementary budget was approved by the Parliament to support, among other things, the government's response to the COVID-19 pandemic. The fiscal balance from previous years was used for the supplementary budget. The government allocated and spent 21.5 billion SLSh from the national reserve (contingency fund). Moreover, the government spent 29.6 billion SLSh to repay domestic loans, 1.2 billion SLSh as a budget subsidy and 2.8 billion SLSh to re-nationalize assets. These expenditures represent 99.3% of the supplementary Budget. The remaining balance on the supplementary budget is 394.1 million SLSh.

Grant receipts and expenditure from the World Bank funded projects in 2020 amounted to 24.7 billion SLSh. This was significantly below the 55.6 billion SLSh approved budget, representing a significant 55.6% underperformance. The CSSP, DRM & PFM, and the SEAP projects spent 7.2 billion SLSh, 11.9 billion SLSh and 3.7 billion SLSh—representing a 59%, 43% and 83% underspend, respectively. Delays or the non-realization in the procurement of high value contracts and assets as a result of COVID-19 induced supply chain disruptions and in one case due to Somaliland's unrecognized status explains most of the underperformances. Furthermore, for the CSSP project, the budgeted amount for certain procurement needs was lower than the market value. Moreover, a few world bank funded consultants were unable to

fulfill their contractual obligations and some budgets for international travel were not realized due to the COVID-19 pandemic.

The fiscal balance in 2020 was 47.8 billion SLSh (excl. the supplementary Budget) and 48.2 billion SLSh including the supplementary Budget. Figure 1 below shows the domestic revenue and expenditure (excl. supplementary budget and WB grants) of the government per year since 2014. Appendix 1 shows a similar trend for the inflation adjusted figures of revenue and expenditure. As can be seen, both revenue and expenditure have been increasing. However, the fiscal balance was in deficit in 2015, 2016 and 2017, resulting in a net deficit of 184.8 billion SLSh between 2014 and 2020. Appendix 1 shows a similar trend for the inflation adjusted figures of revenue and expenditure.

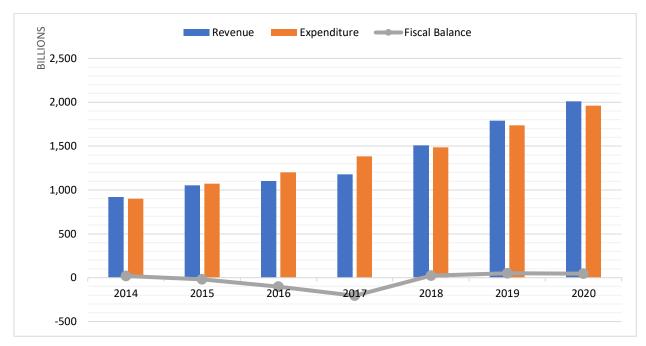

1. Revenue

1.1. Composition of Revenue Collection in 2020

In 2020, total domestic revenue collected in Somaliland was 2.009 trillion SLSh. This is an increase of 12.3% (or 220 billion SLSh) compared to 2019, where 1.789 trillion SLSh was collected.³ Revenue in 2020 was composed of 1.847 trillion SLSh of tax revenue (92%) and 162.5 billion SLSh of non-tax revenue (8%). Compared to 2019, non-tax revenue grew by 30%, while tax revenue grew by 11%. Both increases demonstrate the Government of Somaliland's continued efforts towards improving domestic revenue mobilization.

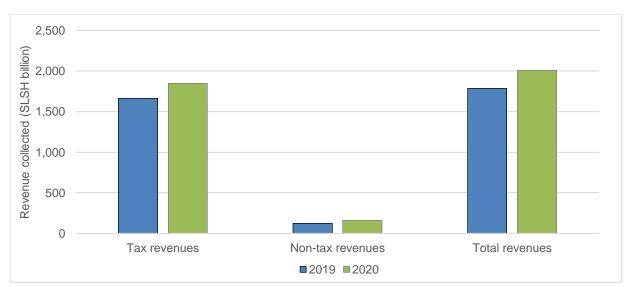


Figure 2: Tax and Non-Tax collection, 2019 & 2020 (SLSh billion)

The largest sources of government revenue for Somaliland in 2020 were taxes on imports, taxes on goods & services and administration taxes. Together, these taxes account for over 59% of total collections. Taxes on imports account for 41% (824 billion SLSh) of total revenue; Somaliland remains largely dependent on imports of goods, while exports remain small. The second largest component of revenue, the tax on goods and services, make up 13% (266 billion SLSh) of total revenue. Collections were marginally lower (1%) than 2019 collections, thought to be linked to Covid-19 restrictions. The third largest item, revenue from administration tax, accounts for 5% (100 billion SLSh) of total revenue. All other revenue items make up the remaining 41% (822 billion SLSh) of total revenue. The composition of revenue is largely unchanged compared to previous years. Notable differences compared to previous years include tax on business income, where the revenue share has increased from 0.7% of total in 2019 to 1.8% in 2020. Moving in the other direction we have GST, where the share declined from 15% to 13%; similarly, revenue from airport charges declined as a share of total. These declining contributions are largely the result of the the Covid19 pandemic.

1.2. 2020 revenue collections by month

Revenue collection was somewhat variable across 2020, particularly during the months of April and May due to the Covid-19 pandemic and some restrictions imposed by the government. In the first five months of 2020, collections were on average 13% below monthly targets, before increasing in the second part of the year. Collections grew on average by 8.5% per month between June and December 2020 and were on average 7% above target. As expected, the strongest performing month was December (SLSh 230 billion, with a close to 26% growth month on month increase). This bump in revenue was due to payment of the port rental fee (28bn), increased imports and additional revenue from other income from post and telecommunication. The final quarter of the year also saw sustained strong revenue collections, with significant increases in November, the second highest performing month, and October, the third highest performing month. The lowest monthly revenue was collected in May (137 billion SLSh, 17% below monthly collection targets).

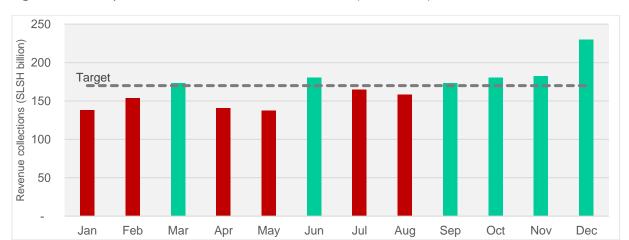


Figure 4: Monthly revenue collection, total revenue 2020 (billion SLSh)

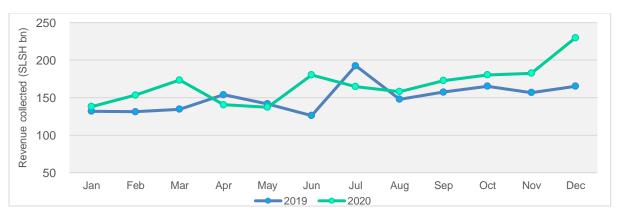


Figure 5: Monthly revenue collection, total revenue 2019 and 2020 (billion SLSh)

Comparing 2019 and 2020, as shown in Figure 5, monthly revenue collection in 2020 were on average 13% higher than those for 2019. Revenue collections were lower in April, May and July, linked to the impacts of the pandemic (trade and movement restrictions in April/May, and the cancellation of the Hajj which normally increases revenue over the summer period in Somaliland). As the two largest revenue items, the monthly trends for revenue from import tax and sales tax largely mirror the overall monthly revenue trend (see Figures 6 below). For both sales and import taxes, April and May were low-performing months. Similarly, October to December were the strongest performing months for both these taxes. For GST, the rebound following the weaker months was slower, with monthly revenue revenues only surpassing 2019 levels in November 2020.

1.3. Revenue collection agencies

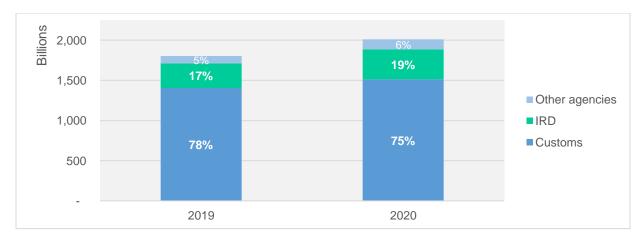


Figure 7: Revenue collected by Customs and IRD in SLSh (million) and % contribution to total, 2019 & 2020

The two major revenue collecting authorities in Somaliland are the Ministry of Finance Development's Customs and Inland Revenue (IRD) departments. In 2020, Customs collected 75% (1.5 trillion SLSh) of revenues and IRD collected 19% (372 billion SLSh) of total revenue; other agencies are responsible for the remaining 6%. As shown in Figure 7, compared to 2019, IRD has gained a slightly larger share of revenue in 2020, compared to 17% (306 billion SLSh) of revenues in 2019, while Customs saw their overall share decrease by 3 percentage points. Despite the reduction in share, Customs revenue collection still grew by 8% (106 billion SLSh) between 2019 and 2020, while revenue collection by IRD increased by 21% (66 billion SLSh) across the period.

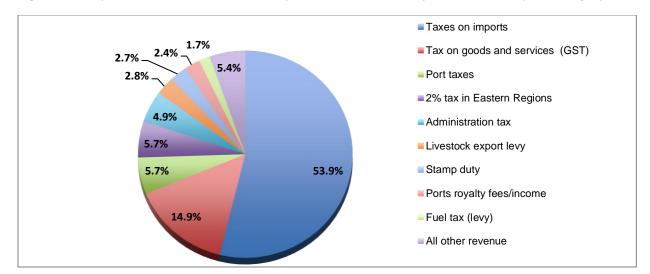


Figure 8: Composition of revenue collected by the Customs Authority in Somaliland by tax category, 2020

The two largest revenue items for Customs are import tax and sales tax, in line with the overall composition of revenue. Figure 8 shows the composition of revenue collected by Customs for 20120. Although the value of revenues collected by Customs has increased significantly over the last year (8%), the composition of revenue remains largely unchanged from 2019, illustrating fairly equivalent growth across the larger tax

items within Customs, although the share of import taxes has increased, while GSTs share has reduced. The major revenue lines appear to have a slightly larger shares in 2020 compared to 2019.

The majority of customs revenues continue to be collected by the Berbera customs station, at the port, where 66.5% of total customs revenues were collected in 2020. Kalabaydh remains the second largest contributor at 21.5% due to khat imports from Ethiopia. The other 18 customs stations collect the remaining 12% of customs revenue. Across 2020, quarter three (Q4) was the highest performing quarter in terms of revenue collection by Customs Stations, followed by the third quarter (Q3). The first two quarters saw significantly lower collections compared to the latter two, as shown in Table 4.

For IRD, the largest revenue item collected in 2020 was taxes on payroll of the public sector, totaling 63.6 billion SLSh and accounting for 14.1% of total IRD collection due to the high number of people employed by the Government of Somaliland. The second largest item was income from the local government supplement at 62.5 billion SLSh. Most of the larger revenue items with IRD have witnessed a reduced share of total revenue, as a number of smaller items start to increase their share including GST, business income tax and administration tax.

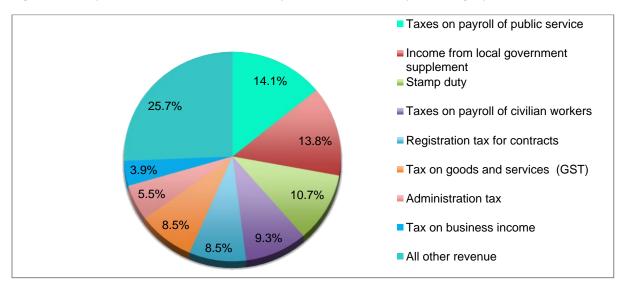


Figure 9: Composition of revenue collected by IRD in Somaliland by tax category, 2020

As shown in Table 5, the majority of IRD revenues were collected by the Hargeisa office, accounting for over 75% of total collections in 2020. As the capital city, Hargeisa is where the majority of public sector workers in Somaliland are based, therefore the largest tax item for IRD, tax on payroll of public service, is highest in Hargeisa. Furthermore, Hargeisa is where most businesses are located, resulting in higher tax take in this area. Berbera comes second with over 14% of all revenues during this period, driven by revenue from sales tax, payroll tax from the private sector and vehicle registration. Other offices accounted for 11% of total IRD collections.

1.4. 2020 Revenue Collection compared to Revenue Targets

The Ministry of Finance Development sets revenue collection targets for each revenue item and for the Customs and IRD stations and offices. In 2020, the overall target for revenue was 2.042 trillion SLSh, including grants from the World Bank⁴, while 2.039 trillion SLSh, excluding grants from the World Bank. As this report is focusing on the performance of domestic revenue collection in 2020, grants from the World Bank will be excluded in this analysis.

Overall revenue collection in 2020 was 2.009 trillion SLSh, below the total collection target by 30.6 billion SLSh. Table 6 provides a summary of the actual performance of the major revenue categories for 2020, compared to their revenue targets. Tax revenue collections for 2020 were 1% (24.6 billion SLSh) below their target, while non-tax revenues saw a 4% (6 billion SLSh) shortfall.

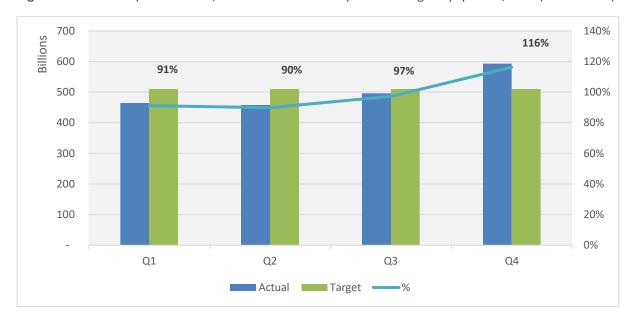


Figure 10: Revenue performance, actual collection compared to target by quarter, 2020(billion SLSh)

Figure 10 shows the overall collection trend, with a gradual increase in collections across the first half of 2020, with collections exceeding the target in the second half of the year. Import duty, the largest revenue item in Somaliland, was the biggest underperformer of the 2020 at 48.2 billion SLSh below its target, linked to the effects of the global COVID-19 pandemic, which reduced international trade. This led to lower-than-average import volumes in the first and the second quarter of the year, as shown in Figure 10. The Government also introduced several measures in response to the COVID19 Pandemic in Q2; the lifting of these restrictions in Q3 led to increased revenue collection in the second half of the year.

1.5. Revenue items

As shown in Table 7, the revenue line that most exceeded the target in 2020 was taxes on port royalty fees, over-performing against the target by 79% (56 billion SLSh). This is likely the result of increases destined for releasing boats for fisheries, as well as higher number of fisheries licenses. Other notable improvements, noted in Table 7, was on income from local government supplement, Registration for contracts, and GST where collections exceeded the revenue target by 3% (7 billion SLSh). Similarly, tax collection from the payroll of public sector workers performed strongly in 2019, collecting an additional 6.7 billion SLSh, 12% over the revenue target. This is likely the result of increased employment in the public sector with the government implementing a new policy to reduce unemployment, particularly youth unemployment. On private payroll tax, which over performed by 15%, early analysis suggests improved compliance from large taxpayers as a key driver.

As shown in Table 8, the revenue line that underperformed most compared to target in 2020 was the import duty due to the COVID-19 pandemic impacting on international trade and some restriction imposed by the government to khat importations. The second largest underperforming revenue item was the Entry fee at Airport, performing 58% (16.3 billion SLSh) below target. Revenue from the entry fee at Egal international airport was affected by the COVID-19 pandemic and the resultant travel restrictions. Livestock export tax and livestock export levy were the third and fourth underperforming items due to the cancelation of hajj in 2020, again, a consequence of the global pandemic.

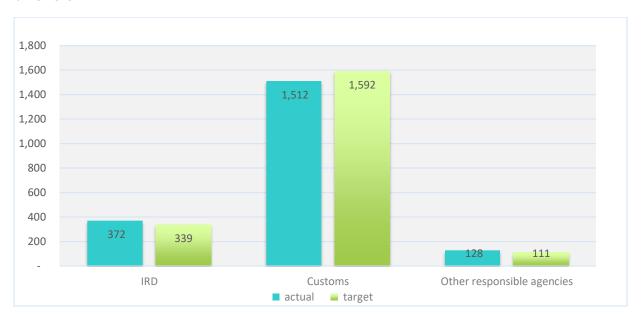

1.6. Targets for revenue agencies

In 2020, the IRD department exceeded its collection target by 10% or 33.4 billion SLSh. This strong performance is expected to be the result of improved efficiency of tax collections, as well as growth in the economy.

Customs experienced a small shortfall of 5% (80.5 billion SLSh) against their overall collections target for 2020. A range of revenue lines collected by customs underperformed, largely linked the pandemic – with all five top underperforming revenue lines under the responsibility of customs (see table 8). Other Agencies outperformed 15% or 16.6 billion SLSh) particularly Ministry of information and awareness, Ministry of fisheries and Ministry of telecommunication.

1.7. Regional performance

Table 9 shows the 2020 performance by each Customs Station in terms of revenue collection against target. Compared to previous year, Berbera strongly underperformed its annual revenue target following the cancellation of hajj and the low volume of imported goods affected by the pandemic. Saylac, Egal Airport in Hargeisa, and Asha Ado were the main underperforming customs stations. The impact of COVID19 pandemic and value of goods imported through Egal, as well as the growth in international arrivals was

lower than anticipated. For Baligubadle, the target was based on 2019 collections; however, 2019 collections were significantly lower since oil from Ethiopia is no longer imported through Baligubadle.

Table 10 shows the 2020 performance by each IRD Office in terms of revenue collection compared to target. Performance within the IRD offices was much more varied than for Customs Stations. Hargeisa and Berbera were the main overperformers, with Hargeisa notably being more than SLSh 15 billion higher the annual target. This follows a rebalancing of revenue targets towards the capital, with most ambitious reform-led revenue increases expected to be delivered by head office.

2. Expenditure

2.1. 2020 Budget and Virements

The 2020 Budget as approved by the Parliament stood at 2.046 trillion SLSh. Table 11 below shows the original Budget allocation by Chapter as approved by the Parliament, the net virements made during the year and the resulting revised allocations (revised budget). Virements allow MDAs to reallocate excess funds from one spending category to another under specific circumstances. As table 11 and Figure 12 show, the virements made in 2020 resulted in a decrease in the budget allocated to *Use of Goods and Services, Government projects* and *loan repayment*; while *Assets, Compensation of employees, grants* and *subsidy* saw their Budgets increase. Appendix 3 shows the specific sub-heads with virements.

2.2. Budget Restrictions

While domestic revenue collection performed really well against target with only a 1.5% deficit, the unprecedented nature of the COVID-19 pandemic led the MoFD, working in tandem with the rest of the government, to restrict several spending items. This was in anticipation of potential spending needs (e.g. health). Table 12 and 13 below lists the spending restrictions that were still in place at the end of the year

by Chapter and Sector, respectively. As can be seen, 56.4 billion SLSh or 2.8% of the National budget was restricted.

At the Chapter level, Assets, Use of Goods & Services, Compensation of Employees and Government Projects saw the biggest restrictions with 21.4 billion SLSh, 19.9 billion SLSh, 10.8 billion SLSh and 4.0 billion SLSh respectively. The Budget for Subsidy was also restricted by 476.2 million SLSh. The restricted amount on compensation of employees corresponds to the portion of the Budget that was allocated for the recruitment of 300 new teachers. Due to the COVID-19 pandemic, this recruitment was postponed to 2021. The restricted amounts on Assets and compensation of employees have been rolled over and added to the 2021 Budget for execution.

2.3. Spend by Chapter

In FY2020, the government spent 962.9 billion SLSh on **compensation of employees**, representing 49.1% of its total expenditure. However, this was 12.9 billion SLSh below the allocated amount or a -1.3% underspend. A breakdown of this category shows that 954.1 billion SLSh was spent on Wages and Salaries, while 8.8 billion SLSh was spent on Social Contributions (i.e. health insurance and national social security schemes). About 98% of the underspend from this category came from wages and salaries. This is due to the fact that several new recruitments were delayed (e.g. to quarter 3 and 4) as a result of disruptions caused by the COVID-19 pandemic, among other things. Most MDAs were operating at less than full capacity for several months in order to enforce social distancing measures.

Expenditure on **Use of Goods and Services** amounted to 547.6 billion SLSh, against a 557.1 billion SLSh allocation—representing a 1.7% underspend. This was 27.9% of the government's total spending in the year. Some of the underspend in this category reflect the social distancing measures enforced in most of the MDAs in order to mitigate the spread of the COVID-19.

Expenditure on the **Government Projects** was 165.0 billion SLSh against a 166.6 billion SLSh allocation, representing a -0.9% underspend.⁵

In FY2020, the government spent 139.9 billion SLSh on **Assets**, representing a 2.9 billion SLSh or 2% underspend against the allocated amount. A breakdown of this category shows that 85% of the spending on assets was on the construction of buildings, purchase of specialized plant, equipment and machinery, and on the purchase of vehicles and other transportation equipment. Spending on the construction of buildings accounted for 58% of the underspend (i.e. -1.7 billion SLSh).

In FY2020, the government spent almost all of the budget allocated for **Loan Repayment**. More specifically, the government spent 82.2 billion SLSh to repay loans, against an 82.3 billion SLSh target—representing a 0.1% or 75.7 million SLSh underspend.

Expenditure on **Grants** was 53.2 billion SLSh. This was 443.1 million SLSh below the allocated amount, representing a 0.8% underspend. A breakdown of this category shows that 47.4 billion SLSh was spent on *Other current grants and transfers*, 5.2 billion SLSh on *Emergency relief and refugee assistance*, and 1.0 billion SLSh on *Scholarships and other educational benefits*. Other Current Grants and Transfers consists of support to various associations and institutions (e.g. Orphan Schools, SOLJA).

The government spent all the amount allocated for **Subsidies** (6.4 billion SLSh) and the funds in the **National Reserve** fund (5 billion SLSh).

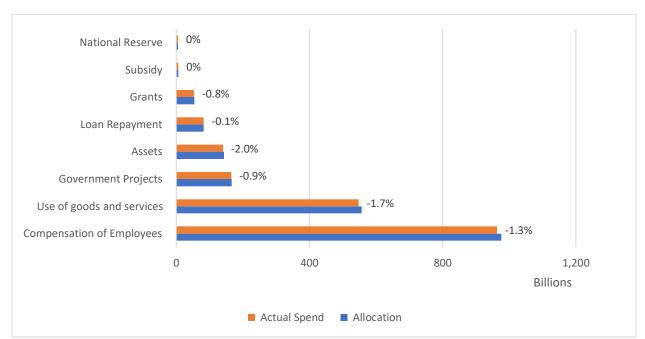


Figure 13: Spend by Chapter in 2020, billions SLSh, percentages represent underspend against allocation

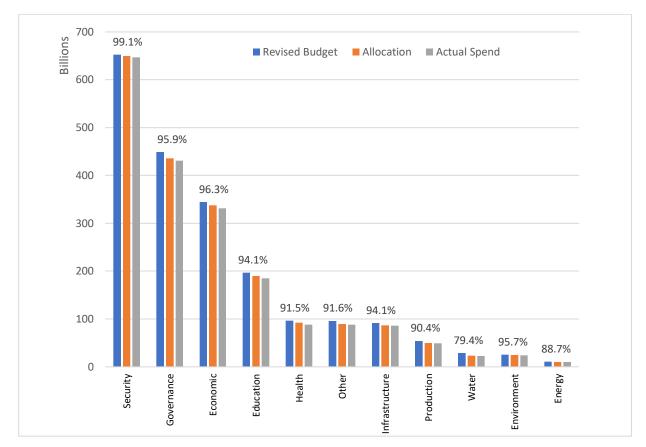
2.4. Spend by Sector

Expenditure at the sector level mirrored the performance at the Chapter level. The Security sector had the best execution against its target with 646.7 billion SLSh—representing a -0.5% underspend against allocation and 99.1% of the Parliament approved budget.

2.5. Government Funded Projects

Expenditure on the Government funded projects performed very well against the allocated amounts and the Parliament approved Budget. The government spent 165.0 billion SLSh of the 166.6 billion SLSh allocated on the projects—representing a 0.9% underspend or -1.6 billion SLSh. About 92% of this underspend came from: the *Agriculture data collection project*, *JPLG support, Support for Dayaxa and Lasanood Schools*, and *the National service Program project*.

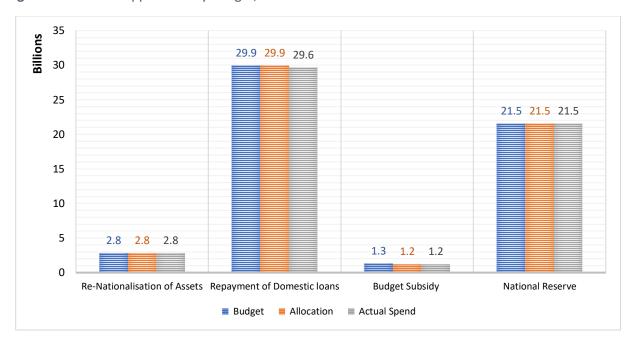
2.6. Supplementary Budget

In FY2020, a 55.6 billion SLSh supplementary budget was prepared by the MoFD and approved by the Parliament to support, among other things, the government's response to the COVID-19 pandemic. The government spent 2.8 billion SLSh to re-nationalize assets, 29.6 billion SLSh to repay domestic loans, 1.2 billion SLSh as a budget subsidy and 21.5 billion SLSh as expenditure from the national reserve (contingency fund). These expenditures represent 99.3% of the supplementary Budget.

Figure 15: FY2020 Supplementary Budget, billion SLSh



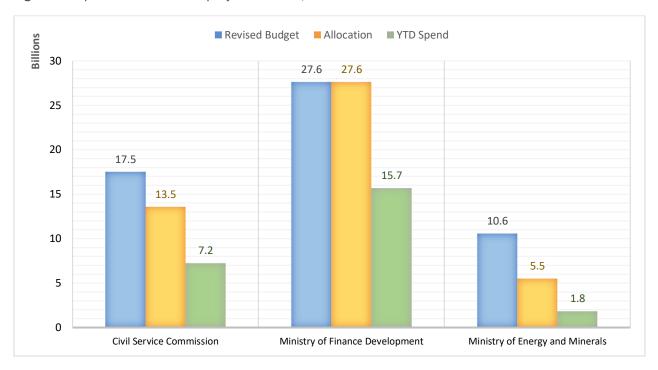
2.7. World Bank Projects

Expenditure on the three World Bank projects significantly fell below target in FY2020. The government spent 24.7 billion SLSh on the projects from a 46.6 billion SLSh allocation—representing a significant 47% or -21.9 billion underspend. This spend amount represents 44% of the Parliament approved budget. The CSSP, DRM & PFM, and the SEAP projects spent 7.2 billion SLSh, 11.9 billion SLSh and 3.7 billion SLSh—representing 47%, 43% and 67% underspend, respectively. Delays in the procurement process explains some of the underspend in the World Bank projects—particularly from the DRM & PFM project.
